ANNUAL MEETING GREAT SUCCESS



The weather was GREAT, we had a good turn-out of members, about 240 people enjoyed a sumptuous Barbecue lunch and we took care of some important Association Business.

The voting was as follows:


- a. Ralph Houck was reelected to the Board.
- b. The new Bylaw Thirteen, that establishes a Replacement Reserve Fund, was approved with 158 votes YES and 62 votes NO on the Issue.
- c. The Pool Enclosure was not approved with 140 votes NO and 89 votes YES, on the issue.

It is of some interest to note that only 229 members voted this year.

We provided every member with Absentee Ballots to allow voting on all the issues. The 229 votes cast represents about one half (50%) of our members.

One would think that an issue that would cost each lot from \$ 225 to \$ 450, if it had been approved, would be worthy of more consideration. After all !! how much effort does it take to mark a few X's on a couple of pieces of paper, place them in the envelope provided, and drop the envelope in the mail??? Was it the 29 cent stamp???

Granted that this was one of the largest votes we have seen on any issue in the last several years. Those of us who did vote have a right to expect many more of our fellow members to take, at the very least, a passing interest in what happens to our Association under the Democratic Voting process.
