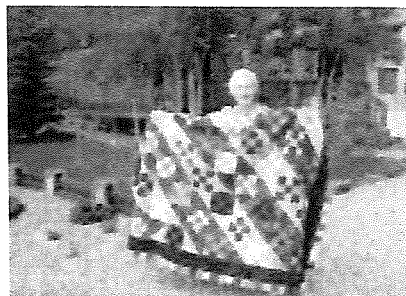
Quilts of Valor

Drop dead gorgeous! That was the remark that one of our CORA members said after she saw the 3 Quilts of Valor completed by our CORA residents.

Eleven women from CORA volunteered their time and talent to make "Quilts of Valor" for our wounded men and women. Over 6,000 quilts nationwide have been sent through the QUILTS OF VALOR program to chaplains at United States military hospitals to be distributed to service men and women seriously wounded in Iraq and Afghanistan. Ellie Payne who headed the CORA efforts wishes to express her gratitude to all who gave gifts of time, labor, money and encouragement. She is especially grateful to the CORA woman who took the time to sew the quilts. Everyone's support will be meaningful to the injured military recipients who will receive quilts made especially for them. Money for the initial supplies for the Quilts of Valor was made possible by our "White Elephant" table, which brought in \$277. Since this was so successful, we plan to continue with it next summer, so please bring in your gently used treasures for the table next summer.

School Donation

And Ellie's quilts keep on giving! Ellie made and raffled off one of her quilts with all proceeds benefiting Fairplay's elementary and middle schools. Thanks in great part to the generosity of many CORA residents, \$566 was raised to purchase school supplies for any child in need. The initial purchase of supplies totaling \$451. was delivered to the school on August 28 with the final purchase of \$105 being made in late September. The Board established a new Policy (2006-5) for water line and sewer breaks under your unit. You will be responsible for moving your unit within 24 hours after the CORA management team contacts you so that the break can be repaired. The complete text of the new policy is on the CORA Website.
