

## Board and Operations are Smooth

Prez's Corner

Happy Holidays!

We've been enjoying exceptionally beautiful weather in Colorado. Some say the credit goes to El Nino or La Nina, but I subscribe to Linda Simonson's theory - it was the purchase of the new snow plow and Don's new insulated snow suit which deterred all wintry weather from the high country.

Although one might think this is a quiet time at CORA, it's very busy behind the scenes. Don installed reflectors on the guardrails protecting those driving up to Silverton Northern. The results are amazing; my thanks to the member who suggested this last Fall. Such a simple safety step

should have been taken a long time ago.

A few items for update. In November, CORA purchased the existing tax lien at the auction Park County conducts each year. The County started with 10 CORA lots listed in the Fairplay Flume and designated to be auctioned; with diligent work, Sherrie at Business Control Systems (through courtesy calls and letters) was able to reduce that down to one.

CORA has made the commitment to acquire these properties. The delinquent taxes and a premium (established by auction) are paid to the County. The buyer pays the taxes for the next 3 years. During this time period, the owner can redeem the property by paying back taxes plus interest and a penalty. Or the property can be forfeited to the tax lien buyer (in this case, CORA), who can then sell the lot to recoup expenses and make a profit.

Unfortunately, the day of the sale this year was not one of those wonderful unseasonably warm days I've been bragging about, but our intrepid Board member Carl Neville (kept warm by wife Ruth) braved the wind and cold and made the successful bid. I promised him a jug of hot

chocolate next year.

One reason Sherrie was able to reduce the number of lots to be auctioned is that she had current addresses and phone numbers for the affected owners. It is vital that you keep us up to date for the many contacts we need to make. Everything from important financial issues to the

status of your property depends on our ability to stay in touch. Please insure that Business Control Systems has your current information at all times.

The Board continues to retain legal counsel concerning the abatement refund, and continues to move forward to resolve this issue. I'll keep you

posted on progress.

In December, the assessment fee statements for 1999 were sent to all members. In order to reduce our postage expenses (which continue to rise), we authorized Business Control Systems to include your electric bill covering the period 4/98 through 9/98, and also to pre-bill the minimum electric charges from 10/98 through 3/99, when the meters will be read again.

Unless you exceed your required minimum charge, you will not be billed again until assessments are sent out for the year 2000. However, an estimated ten members who exceed their minimum amount (\$9.25 for S/N and \$13.00 for the rest) will receive an invoice from Business Control Systems to reflect the actual usage

amount.

The golf course saw a lot more use this last year, as Betty Dale, Al Madsen & George Snyder organized 2 very successful tournaments. Omer and Emma Deem continued to maintain and improve the course to make it a popular asset.

For the use of all owners, Don Olson, Stan Stewart and Paul Pierce continue to provide and

maintain the lawnmowers.

Many other owners are ready volunteers when a project arises, such as fixing leaks, cleanup, mowing common areas, and the kitchen tasks during all-member events; all of this effort is important and much appreciated.

Your Board is striving to maintain the campground facilities in excellent condition for your use, and provide as many activities and options as possible for our growing community.

Prez Report (Cont.)

I realize this was a surprise for most members, especially those who did not attend the most recent Board meeting, in October. The Board approved a 3 percent increase in the assessment fees. This 3 percent will go directly to building up the replacement fund, which is currently at an inadequate level.

Although our insurance will cover property loss, we need to take aggressive action to prepare for the replacement of aging equipment and facilities. It was decided at the October Board meeting that a small increase would be a less painful way to build this fund. Being a fairly new member, I did not realize that CORA's infrastructure is over twenty years old.

The next Board meeting is scheduled for April 17, 1999, at CORA. I encourage all members to attend. This will be followed by a futuring and planning meeting for all members who can attend, on the following weekend, at

the Clubhouse. This meeting on April 24 will be for brainstorming and general discussion of what we all see for CORA in the next 20 years. It isn't practical to to hold this type of meeting in the Winter when so many cannot attend. Please mark this date on your calendar and plan to attend- we'll share ideas and coffee and cake.

On December 8, 1998, a pre-board meeting was held, with no agenda, to help the Board stay in communication between the October and April Board meetings. A second goal was to insure that critical issues were discussed and acknowledged. Minutes were taken and are available, if a member is interested.

And now to the future, with some ideas from

all of us for you to consider.

The budget for 1999 includes a second telephone line. We would like CORA to utilize e-mail and develop a web-site. E-mail provides quick and easy communication. More and more people are using it to stay in touch with family and friends. And today's environment practically demands that any business be online.

The web-site would provide an alternative to (but not replace) the *Hummer*. It would be a quick, up-to-date tool for members to keep abreast of Board meetings, Current and past minutes, weather conditions, how many members have returned for the summer, social activities and important announcements and dates. No matter where you roam, you would be able to go on-line and communicate with the Board and the managers about issues that concern you. The web-site is just an idea kernel, so please give it serious thought and share your ideas with us.

I would also like to know your views on community service in towns like Fairplay, Como, Hartsel, and Alma. Should we take a more active role in these surrounding communities? I know at one time CORA members were participants in Fairplay's Burro

Days - should we expand on that?

Another suggestion is to have a Spring and Fall cleanup. Members would collect trash from their lots and CORA trucks would drive through the campground to pick it up and help with proper disposal.

Will Y2K in the year 2000 affect CORA in any way? Should contingency plans be made?

I personally appreciate those members who have taken the time to call me about their concerns and suggestions for our Campground. And a special thanks to those members I have called, cornered and pummelled with my relentless questions. Until next time,

A while back, I was re-reading some past issues of the *Hummer*. Here's a piece of last

January's:

So far, this winter has been extremely cold in South Park. For six weeks in November and December, we had only 4 mornings with the temperature above zero. massively re-distributed; there are 3-inch skiffs and 7-foot maxi-drifts, depending on location.
