Search for New Managers

With the departure of Don and Linda Simonson, the Board is searching for a new couple to manage the Campground operations. The position requires a broad background of maintenance, public relations, and office skills. In the past, the position has been filled by a couple, due to the time and skills required to fulfill the responsibilities. The job can be very varied, requiring a bit of creativity mixed with perseverance.

#### Senior Activities

Were you aware that there is an organization in Park County that is dedicated to serving seniors?

The Park County Senior Coalition has been in existence for over 20 years, with the mission to serve all citizens sixty (60) years and older who live in the County, in ways that enable them to live in their desired locale for as long as possible.

The Coalition is geographically organized into 4 areas: Platte Canyon, South Park, Lake George, and Guffey. Each area is staffed by a coordinator who is the local contact for the local seniors.

As is typical of the large rural counties of Colorado, the 4 areas, their populations and the motivations of the inhabitants are very different. The key service that threads through them is transportation.

The Coalition operates primarily from grants, with the largest 2 dedicated to transportation (70 % of all funds expended). These provide transportation for medical, shopping and social purposes.

There is also a homemaker grant to provide housekeeping services to those physically unable to provide them for themself. If there is someone residing in the home who can do these tasks, the physically disabled person does not qualify.

Another grant is designed to provide services to low-income seniors in support of Federal objectives. The areas of service are selected anew annually.

The wellness grant is targeted to enhance senior wellness and fitness.

And a handyman program enables the Coalition to help seniors repair and modify their homes so as to make them safer and more functional. This one, as well as several of the other grants, utilizes volunteers to some extent to accomplish the mission.

The Coalition currently owns 4 vans and 1 car. These include a 1996, 14-passenger Diamond with wheelchair lift in Fairplay. As is typical of all rural operations, transportation is one of the greatest needs of the seniors in the County.

There is also a senior center in Fairplay where lunch is served for a nominal fee on Wednesdays. The thrift shop at the Center recycles used items of almost any nature, and the local trips typically leave from this location. If you're interested in more information regarding the Center, call 836-1455 (local).

Trips range from shopping in Denver or Silverthorne (to name a few of these destinations), to a visit to the Garden of the Gods in Colorado Springs or Hudson Gardens in Denver. Cripple Creek is also a popular destination.

Volunteers are always welcome in any notfor-profit organization (eg., the ones at our fine CORA community). If you interested in the services, such as the fun trips or shopping or medical, or would like more volunteer info, call the Coalition at 836-4295.
