

# Pool Enclosure to be Dedicated in Splashy Ceremony

Although the dedication of the new pool enclosure won't be held until Saturday, May 24, at 9:00 AM, the pool has been in use since May 15.

This has been an experiment to determine how many members would use the pool if it were open at this time. The results have been gratifying.

Through the first four days it's been open, 62 people have been swimming. This does not include the 8 folks in the water aerobics group, which meets every weekday at 8:00 AM for the daily hour of workout.

The age of pool-users has ranged from 2 years to 77. This indicates that the 70 degree water temperature and the 76 degree air temperature within the enclosure are satisfying to all ages of swimmers.

The average daytime high temperature for CORA at this time of year is 56 degrees. The wind has been averaging about 18 miles per hour over the past week. Without the enclosure, this combination of wind and temperature would keep all but the hardiest souls out of the water.

This improvement to our Campground is further bolstered by the reduced need to heat the water.

After the enclosure was completed, the pool repairs were finished. The broken tiles were replaced, every seam checked and grouted as needed, and then all was sealed. After Wayne

scrubbed the deck with the high pressure sprayer, he turned on the pool heaters to raise the temperature from the estimated 40 degrees, to just over 70. That took 3 days, which is almost a week less than last year.

Since the water temperature was heated to a swimmable level, the heaters have been working very little. The ambient air temperature holds the water at a very comfortable level, and as the earth surrounding the pool itself warms, that should be enough to reduce the need for heating the water to almost zero.

As mentioned elsewhere in this edition of the **Hummer**, through the profits from the sale of caps, shirts and other apparel, 5 large and 6 small tables and 28 chairs were purchased to place around the pool. These are sturdy plastic, which won't be degraded by the chlorine in the air.

These additions have proven to be quite popular, as grandparents don't choose to stay in the water as long as their eight-year old guests.

Even some non-swimmers have now tried the pool, which probably wouldn't have happened before the enclosure was erected.

All in all, most who have seen the enclosure have stated it's a wonderful addition to our Campground. Those who swim in it echo that sentiment 100 percent.

#### Work Off Lot Taxes

The Board of County Commissioners has just granted a working bonus to those citizens who claim Park County as their domicile of record.

The details of the Senior Tax Work-Off Program have just been completed, enabling taxpayers who are at least 60 years old to work for a County agency at minimum wage (\$4.75) and apply the proceeds to pay their real estate taxes.

Additional requirements are:

\* Must reside at the property address; the property cannot be income producing.

\* Must complete a special program application and submit to Park County Senior Coalition at POB 309, Fairplay, 80440 (See Peter Burton for application packet). \* Must possess the qualifications pertinent to a specific job as requested by a specific County Agency.

Married couples may both work toward the payment of their taxes; however, their combined total income under this program cannot exceed the amount of the County portion of their real estate tax bill. Additional real estate taxes, such as the school tax, are not included in the program.

If the taxes have been paid already by the senior, the tax will be rebated by a refund warrant after the senior delivers the work-off check to the County Treasurer. The taxpayer is responsible for all late penalties accrued, should payment not be made by the established deadlines.

Lot Repairs

The Board asked the Campground Managers to inspect the concrete pads on all the lots in DSP&P, RGS and C&S for deterioration. Letters were sent to all owners whose pads have deteriorated to the extent that repairs are necessary.

These repairs are needed to protect the water and sewer systems. The mains for each of these systems are 10 to 12 feet under ground. The pipes themselves are supported by a bed of gravel. Where the concrete pads have deteriorated extensively, rain and snowmeltflows down the pipes to the main, and can wash out the supporting gravel. to quote from the letter to the owners, "The stress from this may cause the pipes to break, creating a major, and costly, repair project (for CORA).

Under the Campground Rules and Regulations, it is the lot owner's responsibility to correct the

problem.

#### Annual Election

The annual election for new Board members is fast approaching. Note enclosed Nomination Petition.

Petitions must be returned in a timely manner postmarked by June 30, 1997 - in order that they may be processed and the proxies for the election completed for the next mailing.

It has been difficult to find members who will stand for election. The time involved in doing board work is one key consideration. Another is the slings and arrows which are cast when unpopular decisions are made.

It might be interesting to have those who cast the slings and arrows to join the Board, or at least attend a Board meeting, to better understand some of the issues that are considered surrounding a decision.

No matter what your inclination toward standing for election, please think carefully about this matter. If nothing else, make your vote *count*!!!

The icemakers in the kitchen have been replaced, and are working beautifully. The new trash

compactor has also been installed.

### **Facilities Committee**

At the first of the Summer-at-CORA Facilities Committee meetings, it was decided that a pice of CORA common ground would work well for a fire

safety area.

Because fire safety has always been a major consideration in decision making at our Campground, many members have discussed ways to improve safety for those who are staying in Silverton Northern, on top of the ridge.

A piece of common ground has been identified as a logical spot for folks to congregate, should a fire start, and the access road from the top be closed. This is located on the southeast edge of the ridge, near Service Center B.

Maps of this spot will be available by June 1. It's suggested that all members familiarize themselves with the location and terrain, in case a fire should threaten the upper campground.

The Committee also discussed the sale of the fire truck and the grader. No definitive offers have been received for either piece of equipment as of press time.

The Committee meets on the second Sunday of each Summer month, at 2 PM, in the Clubhouse. Everyone is welcome - it would be good to see you there!

often stretch that to 2 miles).


