Paul and Debbie Gentry were hired as the on-site managers for the Campground. You will read more about them elsewhere in this

Hummer. A huge "thank you" to Marge and Paul for their work over the summer; without the wonderful members pitching in, CORA just wouldn't be the wonderful place that it is.

Also, I would like to thank all those volunteers in our park who have stepped up to help when other needs arose. I know there are many who diligently maintain the roads, cut weeds and mow grass, and cover for the managers (including Paul and Marge) on their days off. And a big thanks to those who are responsible for stocking the the freezer with ice cream bars!! All of you are the unsung heroes many of us don't recognize.

A special thanks to those individuals who helped in the several medical emergencies that occured in July. Especially those where the *Flight for Life* was called in - it's a wonderful reflection on our community when we pull

together in a time of crisis.

Since there have been many medical emergencies, I want to remind everyone that there are oxygen tanks and first aid kits in each of the CORA trucks, as well as in the kitchen of the Clubhouse. There should be emergency numbers for our surrounding area posted on all the bulletin boards. If these are missing from one, please contact Debbie or Paul to have this rectified.

The Board meetings over the summer were very productive. In July, motions were carried to side or roof the sewer plant and the Silverton-Northern service centers. Also, it was voted to accept Chimincas, or the bee-hive shaped Mexican ovens. These must have a screen on the chimney and the opening in the front. They must be placed on a concrete base or pad regardless of whether they are on a deck or the ground. Please talk to the managers if you have safety questions.

Remember: According to the fire district, each individual is responsible for his or her fire, and can be required to reimburse the cost

of fighting a runaway fire.

It needs to be clarified that motorcycles are permitted at CORA if properly licensed and street legal. Apparently, with all the

discussion, there has been some confusion about this.

Also in July, the Board approved using 120 gallon tanks for propane. Fishing permits will be issued for next year; the one dollar charge has been dropped. Additionally, copies of the Board Meeting agenda and minutes are free if you get them from the CORA office; there is a charge when Business Systems provides them.

The Board took the suggestions from the July covenant meeting back to the attorney to determine the best approach for presenting the package to the members. The goal is to vote this year. The package was then sent to all members prior to the August Board Meeting. There are 2 important reasons why all members need to return the completed ballot as soon as possible: There must be a large percentage of "yes" votes before the covenants can be changed, and it is quite expensive to re-mail the packet to members who have not returned theirs. Since this is money out of your pocket, please respond as soon as possible with your ballot.

PRESIDENT'S UPDATE

I'm looking for volunteers to take over for Peter Burton. Please call me if you have an interest in editing the Hummer. During the winter months, a much shorter version of the Hummer will be sent. The next one will be sent with the December 1st invoices.

My sincere thanks to Peter for the great job he's done since I've been part of the CORA family. The Board wishes him congratulations and good luck on his new adventure.

Also the Board approved the budget which calls for adding washers and dryers to Service Center A at the Silverton-Northern campground. This should help take the load off of the facilities at the Clubhouse.

In addition, we have been given the okay from our attorneys at Orten & Hindman to place seasonal workers on common ground. We are taking applications for two couples. One must reside at SN on the space created adjacent to Service Center A. Please contact the managers for more details. It's a May-October term.

Also in my column this edition, I mentioned the oxygen tanks provided at CORA. Debbie, our manager, found out that we <u>cannot</u>, legally, dispense oxygen. It is considered a drug and needs a prescription. So those tanks will be removed.

The most important update is the approval of the Amended and Restated Declaration of Covenants. Please sign (must be identical to the signature on your title) and return your consent form for the Covenants. The Board believes these new changes are great for our association. Here are some of the benefits:

- The Association's documents have been brought into compliance with the Colorado Common Interest
 Ownership Act to the extent this Act is applicable to communities created prior to July 1, 1992. In a
 nutshell, these revisions provide the Board and the Association with broader rights and protection under
 Colorado law.
- Additional flexibility with respect to your campsites will be incorporated. These revisions permit the
 association to plow the roads to Silverton-Northern, opening and closing the service facilities is more
 flexible (based on weather conditions), and trailers no longer have to be moved on and off lots as now
 stated.
- Restrictions are more flexible. Specifically, the Board of Directors has the authority to grant approval for
 extension cords, fire pits and other fire facilities which meet County fire regulations and if approved by line
 item, other vehicle use. If you don't want ATVs, golf carts, snowmobiles or trail bikes to be permitted, just
 check the no boxes on the consent form. This way we can still adopt the new Amended and Restated
 Declaration of Covenants.
- The proposed Covenants update and clarify your current insurance provisions.
- The enforcement section of the Covenants has been updated to provide all owners with certain due process rights prior to the Association filing a lawsuit to enforce covenants.

Please join the Board of Directors in supporting these documents which help our Association comply with Colorado law and provide you, the owner, more rights and flexibility in enjoying your campsite.

We have included a consent form for your convenience. If you have already mailed it in, the Board thanks you for your support. If you wish to have your consent form returned please contact Business Control Systems at 303-762-8829. Remember if you don't send in the consent form, it is an automatic no. Please help us improve and preserve our beautiful mountain community by returning the signed consent form. We will all benefit from these changes. Board Matters

Board Members - When the Board, with the newly elected member, met after the Annual Meeting, only 4 members could be seated. Bruce Lindal was the lone member, whose term was completed, who chose to run for an additional term.

Following procedure, the first order of business was to elect officers for the next Board-year (Annual Meeting to Annual Meeting). Your current Board is:

When there is a Board vacancy, the By-Laws require the President to ask for volunteers to be appointed to complete the vacant term. If there are more volunteers than openings, the seated Board determines who will fill the vacancies.

As of this writing, the Board has received 4 applications for the current 3 un-filled seats. These brave and responsible volunteers are Larry Lightfoot, Roy Bahr, Larry Payne, and Al Madsen.

Applications will continue to be received at Business Control Systems by October 16. All applications received by the deadline will be considered by the sitting Board at the October 16 Board Meeting.

If you are considering volunteering for one of the vacant positions, <u>hurry</u> - there's not much time remaining to step forward.

Budget - The budget proposed for 2000 by the Budget Committee was passed by the Board. This included association fee increases of 3%, which raises Silverton Northern fees by \$9 to \$314, and DSP/CS/RGS fees \$13 to a total of \$436.

The increased fees, presumably including the increases which were authorized for 1999, are designated to help re-build the reserve fund. Keep in mind that this is really an investment account, in that it is considered savings for a rainy day. Should you sell your lot, your portion of the amount in reserves accrues to the new owner, and can be included in the asking price for your lot.

Miscellaneous - Handicap upgrades are continuing. Service centers are being modified to accomodate those who need special consideration.

The tax lien sale occurs in November. Terry Bahner and someone from Business Control are planning to attend.

Thank you to the 3 Board Members who left the Board this last year. Your work was much appreciated!
