- a. Bridge to shop washed out from flood. Tom has been working on repairing/cleaning up debris in the bridge area.
- b. Pool Drain/walls of pool -
 - 1. Mark is working bid from a company in Denver. Mark feels very positive about the bid and cost factor.
 - 2. Tom already has one bid \$7,500 for drain and \$40K for all
- c. Sewer line is collapsing under pool bathrooms-need bids.
 - 1. Loren Woods offer to help bid information.
 - 2. Brandon Walker suggested that we reach out to Denis Breuer RGS13 & RGS14 for counseling on possible solutions concerning the collapsed sewer.
