 - a. Special Presentation: Hartsel Fire Department, Northwest Fire District Arranged by Milt Shaw
 - b. Trevor Lafferty and Nick Varma were primary Speakers
 - c. Nick described his experience on 'our' fire.
 - i. Firefighters from 27 states were here
 - ii. Smoke jumpers were used to get into remote areas to combat the fire and develop breaks.
 - iii. Breaks did not hold and additional equipment had to be used
 - iv. Biggest threat to CORA was S&N. The trees are stressed from prolonged drought and will not recover for 5 7 years.
 - v. Asked us to help them by using the Fire Wise program
 - 1. Clean up our lots of dead or fallen trees
 - 2. 100 -150 feet of clear land around structures
 - 3. Thin 10 feet between trees
 - 4. Keep grasses low
 - 5. Clean up pine needles
 - 6. Certified Fire Marshall will come up to review properties
 - vi. Questions were asked about all the propane tanks
 - 1. Propane tanks are safe if they do not have fuel around them
 - 2. Observed firewood stacked in front of tanks need to move
 - 3. Knock down all weeds around tanks clear the area of anything burnable
 - 4. Some firefighters will not go to a fire with propane tanks
 - vii. The fire department will be glad to come back to speak again
