- g. Sewer Phil and the pump company came out to inspect the sewer.
  - i. One pump has had to be totally replaced it cannot be rebuilt.
  - ii. The other pump is still working but needs to be replaced
  - iii. Bases, flanges, some pipes, and electric work must be done
  - iv. Bruce joked about everyone needing to stop all bathroom and waste disposal for a few days while the work is being done. The plant has to be totally shutdown and drained for the work to occur.
  - v. Joyce reported cost will be between \$20,000 and \$25,000 for the work,
- h. Propane Detector The propane detector in the clubhouse malfunctioned and shut all propane off to the clubhouse complex. Phil (from the sewer plant company) disarmed it but it has to be replaced. Bruce informed anyone who smells propane in the building leave immediately.
- i. Electric Meters Thanks to Jasmin, Terry and Kathy all meters in C&S, DSP, and RGS have been read.
- j. Pool Has been used a lot this year. We have plaster separating from the bottom in the shallow end. Linda Starr loaned a big mat being used to cover it.
  - i. Filter valve leaking
  - ii. Mark to cover rest of issues
- k. Buffalo Peak Reservoir
  - i. Ric, Mary, and I attended the annual RORA/CORA water meeting
  - ii. PH level remains high fish cannot live in the water
  - iii. September another water test will occur
  - iv. If possible; a small test stocking will occur
