a) Office

6. TREASURER'S REPORT

- a) Analysis of Edward Jones Reserve Accounts as of February 15, 2023, showed a total of \$812,759 with \$662, 553 in the advisory account and \$150,206 consisting of money market and CD's. As the \$662,553 consists of securities such as stock and bonds, it will fluctuate daily, whereas the other account is secure and will increase in value as it matures.
- b) After analyzing the advisory account, it appeared than 2022 showed a return of -12.47% while the first 46 days of 2023 showed a positive return of 4.37, which causes me to be cautiously optimistic about recouping some of our losses. Of course, all of this is subject to change without notice, but our portfolio is fairly conservative so, hopefully, this will be a better year.
- c) We should recoup some by taking advantage of the CD rates while the interest rates are still high.
